REVIEW OF FEBRUARY 5, 2015 JAPC NOTES

The Committee reviewed the notes.

DISCUSSION TOPICS**ACCIDENT ANALYSIS**

Committee members were provided with a 2015 YTD report listing all reported injuries and work hours in POLA/POLB.

The committee was also provided with the LA/LB injury summary report covering 3/01 to 4/1/2015. The report listed 30 LT and 17 NLT injuries for LA/LB. Members were reminded to review the injury report and follow-up with either the employer or the Secretary if additional information/details are requested. The Union requested that an advance copy of the monthly injury report be distributed on the 15th of the month.

SERIOUS ACCIDENTS

1. A POLB container terminal safety manager described a recent injury in which a swingman walked across the top of a container, over the guardrail, and S&F to the deck resulting in a broken tibia and wrist.

The committee then discussed the fire department response to the incident. The foremen representative noted the FD could not access the back gate. The employer representative noted the fire department chose not to use the back gate and that they have a key to enter. The Union noted they will follow-up with the terminal.

2. The committee was briefed on a longshore fatality in Nigeria.
