PAID HOLIDAY, FRIDAY, JULY 4TH – INDEPENDENCE DAY – Is a normal work day and an automatic holiday for those members who worked at least 1300 hours (1200 hours if age 60 or over) in 2013. For those members who did not meet the automatic holiday requirements, they must be available for work at least two (2) of the four (4) days exclusive of the holiday (Monday, Tuesday, Wednesday, or Thursday, June 30th, July 1st, 2nd or 3rd). If a member worked less than 1300 hours but at least 800 hours (700 if age 60 or over) and is on disability during the holiday week, he/she must request the Business Office to file a claim on their behalf or if on vacation during the holiday week, notify the Records Clerk. Reminder – only those members who worked at least 800 hours (700 if age 60 or over) in 2013 are entitled to receive or file for paid holidays.

NO WORK HOLIDAY, SATURDAY, JULY 5TH – BLOODY THURSDAY – Is a dead day. As was agreed-to in past negotiations, Bloody Thursday is a no work holiday, but is NOT a paid holiday. No work shall be performed between 8:00 a.m. July 5th and 8:00 a.m. July 6th, except for military cargo, passenger vessels, and on-dock rail. As the holiday occurs on a weekend, Monday, July 7th will be paid at the over-time rate only for those who work that day.

<u>CLARIFICATION FOR WORKING RULE P-15</u> – SUPERCARGO QUALIFIES FOR CREDIT - "Any marine clerk who volunteers for any 30% jobs on the day side may use that job for credit toward qualifying for Key or Basic". <u>Clarification</u>: when working as a Supercargo each day (initial starts and comebacks) may be counted toward Key and Basic qualifying.

<u>TWIC CARDS</u> – The TWIC office has now re-opened. Please check the date on your card; do not allow your card to expire and lose valuable work days unnecessarily.

ONGOING DESMOND BRIDGE CLOSURES – As preparation for the Gerald Desmond Bridge Replacement Project, the contractor closed the southbound I-710 freeway to westbound Ocean Blvd. connector ramp as of May 10th. The connector will be demolished to clear a path for the new bridge foundations. The closure will remain in effect for approximately 30-months until the new bridge and approach structures are constructed. <u>REMINDER TO ALL CLERKS</u> – PCMSC Rule 907 – "A vehicle operator shall carry out the following procedures: set brakes and shut off motor when leaving vehicle".
