The Business Office will be closed on Monday, May 28th in observance of the Memorial Day holiday.

PAID HOLIDAY – MONDAY, MAY 28TH – MEMORIAL DAY – is an automatic holiday for those members who worked at least 1300 hours (1200 if age 60 or over) in 2011. For those members who did not meet the automatic holiday requirements, you must be available for work at least two (2) of the four (4) days exclusive of the holiday, (Tuesday, Wednesday, Thursday, or Friday, May 29th, 30th, 31st, or June 1st). If you worked less than 1300 hours and are on disability during the holiday week, you must request the Business Office to file a claim on your behalf; or if on vacation that week, notify the Records Clerk. Reminder – only those members who worked at least 800 hours (700 hours if age 60 or over) in 2011 are entitled to receive or file claims for paid holidays.

WELFARE PLAN OPEN ENROLLMENT — Any active or retired member who wishes to change his/her medical and/or dental plan may do so during the month of May by completing the appropriate form(s) in the Business Office; the change will then take effect on July 1st. This enrollment month is in addition to one (1) month of the member's choice during the year who may wish to change their medical and/or dental coverage(s).

<u>ILWU SCHOLARSHIPS</u> – The list of schools that have scholarship applications available to graduating students is posted on the Local's website. Each school has its own application and selection process; for additional information check the website.

SOUTHERN CALIFORNIA AREA WELFARE DIRECTOR – Sam Alvarado will be present on the 2^{nd} and 4^{th} Thursday of each month from 10:30 a.m. to 5:00 p.m. for any Local 63 members who are in need of his services. Members *may* receive up to an additional 200 hours with the appropriate medical documentation to help them qualify for a good pension year if they have not already filed a claim for that year.

<u>RULE REMINDERS</u> - The Officers have again received numerous complaints on the following PCMSC Rules and remind members to report the following issues to their immediate supervisors on the job to avoid complaints being filed against them for not reporting.

Duties of Employees:

Rule 602: An injury of any kind, irrespective of its severity, shall be reported immediately to the foreman, walking boss, or man in charge of operations, by the injured person, if they are physically able to do so. If not, the injury shall be reported by any other person in possession of the facts.

A Vehicle Operator shall carry out the following duties:

Rule 901: Shall test brakes, shifting mechanisms, accelerator mechanisms, windshield wipers, steering gear, warning safety lights, horn and, where equipped, seat belts and mechanisms for raising, lowering and tilting before starting work. Upon completion of the inspection, the vehicle operator shall immediately report any defects to the foreman, walking boss or other employer representative on the job, who shall act promptly to correct the defect in the gear, vehicle, machinery or any unsafe working condition.
