1. Industry Travel

The Committee met to review the restrictions on voluntary and ordered travel agreed to in CLRC Mtg. No. 10-20, CLRC Mtg. No. 11-20, CLRC Mtg. No. 16-20, and CLRC Mtg. No. 22-20.

After discussion, the Committee agreed to lift, in phases, industry travel restrictions. The first phase was a Coastwise suspension of all travel, the second phase will allow for some, but not all travel. The phased lifting of travel will be monitored by the Committee to address issues should a problem arise. The Committee agreed to immediately advise the JPLRCs of this decision and to direct the JPLRCs to notify all registered workers in their jurisdiction of the easing of voluntary and ordered travel as outlined below.

Puget Sound Area/Washington Coast

All voluntary and ordered travel within the defined area of Puget Sound Area/Washington Coast, as outlined in Supplement IV of the PCLCD, is allowed effective Saturday, May 30, 2020. For the purpose of determining availability requirements for PGP benefits, only home port work opportunities will be considered during this time period. Travel outside of this defined area remains restricted.

Columbia River/Oregon Coast

All voluntary and ordered travel within the defined area of Columbia River/Oregon Coast, as outlined in Supplement IV of the PCLCD, is allowed effective Saturday, May 30, 2020. For the purpose of determining availability requirements for PGP benefits, only home port work opportunities will be considered during this time period. Travel outside of this defined area remains restricted.

Northern California Area

All voluntary and ordered travel between the Ports of Stockton and West Sacramento is allowed effective Saturday, May 30, 2020. For the purpose of determining availability requirements for PGP benefits, only home port work opportunities will be considered during this time period. Travel into and out of the San Francisco/Bay Area Ports (San Francisco, Oakland, Redwood City, Richmond, Benicia, Crockett, and Concord) and Eureka remains restricted.

Southern California Area

All travel in Southern California Area remains restricted.

The Committee further agreed that the travel restrictions outlined above that begin on May 30, 2020 shall remain in place for the next 30 days. The Committee shall meet to revisit the issue and determine the next appropriate steps following the 30-day period.
