CONSTITUTIONAL QUESTIONS

As recommended by the Local 63 Trustees and approved at the 10/17/2024 Local 63 Executive Board Meeting and 11/07/2024 and 1/09/2025 Local 63 Stop Work Membership Meetings, are you in favor of amending Appendix, Section 1.D. of the Local 63 Constitution as shown below?

CURRENT LANGUAGE: Appendix, Section 1. D.

All members are required to attend the regular membership meeting of the Local or be fined five dollars (\$5.00). This shall not apply to members who are sick (doctor's certificate), injured (or Worker's Compensation), working, or on vacation (maximum one (1) meeting per year). In addition, members shall be entitled to be excused from attending any two (2) meetings per year. Furthermore, members sixty (60) years of age or over, who have five (5) years as a Class "A" Marine Clerk, and have cleared with the Business Office, are also excused.

PROPOSED NEW LANGUAGE (showing proposed revisions): Appendix, Section 1. D.

All members are required to attend the regular membership meeting of the Local or be fined ~~five dollars (\$5.00)~~ **fifteen dollars (\$15.00)**. This shall not apply to members who are sick (doctor's certificate), injured (or Worker's Compensation), ~~or working. or on vacation (maximum one (1) meeting per year).~~ In addition, ~~members shall be entitled to be excused from attending any two (2) meetings per year.~~ Furthermore, members sixty (60) years of age or over, who have five (5) years as a Class "A" Marine Clerk, and have cleared with the Business Office, are also excused.
